FND Hope UK is part of the first and only global patient-led charity for people with Functional Neurological Disorder and is 100% volunteer led.

Originating as a grassroots campaign, it uncovers the hidden world of FND and empowers those affected to live their best possible life. Our mission is to promote awareness, support affected individuals, and advance research for the prevention, treatment and recovery of FND. FND Hope UK was the first non-profit in England and Wales providing support for those throughout the UK. Due to hard work and dedication of a few UK advocates, patients and medical professionals working together, FND Hope UK became a registered Charitable Incorporated Organisation on the 28th June 2017 in England and Wales and a registered charity in Scotland on the 24th April 2018.

Treasurer

- Overseeing, approving and presenting budgets, accounts and financial statements to the board
- Ensuring that the charity has an appropriate reserves policy
- Ensuring that appropriate accounting procedures and controls are in place
- Advising on the financial implications of the organisation's strategic plans
- Ensuring that the accounts are prepared and disclosed in the form required by funders and the relevant statutory bodies, for example the Charity Commission and/or the Registrar of Companies and or Office of Scotland Register (OSCR)
- If external scrutiny of accounts is required, ensuring that the accounts are scrutinised in the manner required (independent examination or audit) and any recommendations are implemented
- Keeping the board informed about its financial duties and responsibilities
- Contributing to the fundraising strategy of the organisation

Time commitment

Trustees are required to attend 6 weekly UK Board meetings which are normally held via Zoom. Trustees are expected to attend key organisational events, such as annual conventions and to support the Executive Director in projects associated with their skill set. Overall the amount of time which we would expect you to commit to the charity will be:

Trustees – approx 24 days per year. Treasurer - approx 24 days per year.

Expenses

While this role is not remunerated, Trustees will receive reimbursement for reasonable expenses incurred during work on behalf of FND Hope UK.
