

CCG/Health Board Report 2022

In December 2021 and following discussions with the UK Medical Expert Committee which comprises of 21 Medical and Allied Health Professionals across the UK, we agreed to send a Freedom of Information request to each CCG and Health Board in England, Wales and Scotland.

This project aimed to explore issues reported by NHS clinicians and the FND community regarding accesses to treatment for people with FND. Anecdotal feedback was that some CCG's / Health Boards exclude people with FND from accessing physiotherapy, occupational therapy, speech and language therapy, and/or psychology. A common reason given is that they are not commissioned to treat this condition. Following discussion, FND Hope UK reached out to all CCG's in England and Health Boards in Wales and Scotland to determine the following questions

- 1. Does your commissioning agreement within your CCG include treatment for Functional Neurological Disorder?
- 2. Can you please confirm that the commissioning agreement within your CCG provides each of the following services and that people with FND are eligible to be referred and receive this treatment:
 - Neurological physiotherapy
 - Neurological occupational therapy
 - Speech and language therapy and
 - Psychological therapies
- 3. Can you please provide a list of the services offered and contact details which include both Inpatient and Community/Outpatient Rehabilitation Services as advised in Q2?
- 4. If your commissioning agreement excludes the treatment of Functional Neurological Disorder, can you please provide details of which services in your CCG Areas accepts referrals for treatment for Functional Neurological Disorder?
- 5. Do you have plans to improve access to treatment for people with FND? If so, can you provide details of what improvements are being implemented?
- 6. Would you or your colleagues be interested in accessing clinical support/education about FND involving specialist clinicians?

We contacted a total of 126 CCG's/Health Boards during December 2021 with FOI requests.

- 105 CCG's in England
- 7 Health Board in Wales
- 14 Health Boards in Scotland

Functional Neurological Disorder (FND) is one of the commonest reasons for people to see a neurologist. It is a condition that can cause a wide range of symptoms such as paralysis, seizures, tremors and loss of sensation. Historically it has been a marginalised illness, often falling down the gap between the artificial divide between neurology and psychiatry, with patients often told that symptoms are not real or imagined. However, FND remains a serious and often long-term condition, with levels of disability and impaired quality of life similar to that seen in people with MS or Parkinson's disease.

Set against this challenging background, there has been a remarkable increase in patient, clinician and academic activity and engagement in FND over the past 15 years. This has led to new insights into the pathophysiology of the condition, new evidence for successful treatment, development of an international health professionals' society and development of national and international patient charities. This work has continued to highlight the health inequalities faced by people with FND, especially in access to treatment.

We recently surveyed, through a Freedom of Information request, all of the Clinical Commissioning Groups and health boards in the UK as to their current provision of multidisciplinary rehabilitation for people with FND, as well as if they had active plans for developing or expanding services.

We found that:

- 50% of UK health boards / CCG's had no specific agreement to treat FND or did not treat FND, and almost 10% say that they do not accept referrals for treatment
- Between 14% (England), 21% (Scotland) and 43% (Wales) of services said that they did not accept physiotherapy referrals or provide physio for FND. Less than half (43%) said they had neurological physiotherapy services which would accept people with FND.
- Between 22% (England), 21% (Scotland) and 43% (Wales) of services said that they did not accept occupational therapy referrals or provide occupational health for FND and less than half (41%) said they had neurology based occupational therapy services which would accept people with FND.
- Between 17% (England), 14% (Scotland) and 43% (Wales) of services said that they did not accept speech and language therapy referrals or provide speech and language for FND and only 39% said they had neurology based speech and language therapy services which would accept people with FND.
- Between 16% (England), 29% (Scotland) and 43% (Wales) of services said that they did not accept psychology referrals or provide psychological therapy for FND, whilst 42% said they would accept people with FND.
- Only 35% said they had plans to improve their services for people with FND and only 35% said they were potentially interested in accessing further education or support to improve services.

This survey highlights the current patchy and inequitable provision of rehabilitative services for people with one of the commonest causes of neurological disability.

information supplied by the CCG / Health Board. Between 16% (England), 29% (Scotland) and 43% (Wales) of services said that they did not accept psychology referrals or provide psychological therapy for FND, whilst 42% said they would accept people with FND.

 We found four (4) offered IAPT services as part of their criteria (This is based on the information supplied by the CCG), two (2) did not offer IAPT as per reason: Under the service specification for Improving Access to Psychological Therapies (IAPT), FND would be classed as exclusion and patients with FND would need to be seen by a specialist service which we don't have a commissioned service for and one (1) is currently reviewing business case to incorporate IAPT Services

- 8 did offer treatment including general services and did not have plans to improve services
- 3 advised referrals were not accepted, and did not have plans to improve services
- 20 advised information was not available from the CCG.

Of the 15 that answered not applicable:

- 11 did offer treatment, including general services and did not have plans to improve services
- 4 advised information not available from the CCG.

Of the 43 who answered no?

- 40 offered treatment including general services
- 2 did not accept referrals and did not have plans to improve services
- 1 advised information not available from the CCG

Comments received

No and referrals not accepted

"The Planned and Specialist Team do not commission any services for FND patients. Despite "neurological" in the name, it is not considered a neurological condition, i.e. the patient's neurology is functioning properly. For this reason, the units we commission for specialist inpatient rehabilitation do not accept FND patients" CCG

"The CCG does not specifically include the treatment of FND in its current commissioning agreements" CCG

"No, therefore all other responses would be N/A" CCG

"Health Board (the UHB) does not provide treatment for FND. UHB Consultants diagnose FND in our neurology clinics – there are no consultants in the HB area that are specialising or leading on this currently". Wales Health Board

"The Health Board does not have a specific service for functional neurological disorder (FND)." Wales Health Board

"CCG have identified in year a commissioning gap in relation to treatment for patients diagnosed with FND. A Business Case has been developed which is currently being taken through our internal governance process with a view of working with our Community Neuro service to implement within the New Year. This will include a combination of physical therapy (with physiotherapy and occupational therapy input) and mental health support via Improving Access to Psychological Therapies – Long Term Conditions (IAPT-LTCs). It is envisioned that Consultants and GPs will be able to refer any X patient, with a diagnosis of FND into this service to receive both physical and mental health support" CCG



No, but some provision of treatment

"The CCG does not specifically commission an FND clinic in the community but the community provider provides support for patients diagnosed with FND". CCG

"CCG does not commission a specific service for this disorder. Patients will be treated within the specialties listed"

"Individuals can access discipline specific interventions from clinicians who have an interest in the condition and who have some capacity to provide this care. Some persons with FND are seen within mental health services if they meet criteria for these services and the neuro physio department in HB also accepts referrals for FND". Wales Health Board

"Health Board does not provide inclusive treatment for Functional Neurological Disorder" Scotland Health Board

Moving forward

The anecdotal reports of FND being excluded from treatment were supported by our data, with 50% of UK Health Boards/CCGs having no specific agreement to treat / not treat FND.

People with FND experience disabling neurological symptoms that often persist in the long term. There are promising, evidence-based treatments available on the NHS, but access is patchy and waiting times for treatment tend to be very long; which may potentially limit their effectiveness as longer symptom duration is associated with worse outcomes.

Improving access to treatment for FND should be a high priority for the NHS, on the grounds of the potential cost savings, but more importantly to limit distress and disability of large portion of the community.
